**PLEASE TAKE FURTHER NOTICE** that on January 5, 2024, the Debtors filed (a) the *Amended Joint Chapter 11 Plan of Reorganization of Endo International plc and its Affiliated Debtors* [Docket No. 3523] and (b) the *Disclosure Statement with Respect to the Amended Joint Chapter 11 Plan of Reorganization of Endo International plc and its Affiliated Debtors* [Docket No. 3524].

**PLEASE TAKE FURTHER NOTICE** that on January 9, 2024, the Debtors filed (a) the *Second Amended Joint Chapter 11 Plan of Reorganization of Endo International plc and its Affiliated Debtors* [Docket No. 3535] (the “Second Amended Plan”)<sup>2</sup> and (b) the *Disclosure Statement with Respect to the Second Amended Joint Chapter 11 Plan of Reorganization of Endo International plc and its Affiliated Debtors* [Docket No. 3536] (the “Disclosure Statement”).

**PLEASE TAKE FURTHER NOTICE** that a hearing (the “Hearing”) to consider the Motion, among other matters, took place on January 9, 2024, at 3:00 p.m. (prevailing Eastern Time) before the Honorable James L. Garrity, Jr., United States Bankruptcy Judge, United States Bankruptcy Court for the Southern District of New York, One Bowling Green, New York, NY 10004 (the “Court”).

**PLEASE TAKE FURTHER NOTICE** that, at the Hearing, the Court approved the Disclosure Statement on a conditional basis and the Motion.

**PLEASE TAKE FURTHER NOTICE** that on January 12, 2024, the Debtors filed a revised *Disclosure Statement with Respect to the Second Amended Joint Chapter 11 Plan of*

**PLEASE TAKE FURTHER NOTICE** that on January 12, 2024, the Court entered the *Order (I) Scheduling a Combined Hearing for Approval of the Disclosure Statement and Confirmation of the Plan; (II) Conditionally Approving the Adequacy of the Disclosure Statement; (III) Approving (A) Procedures for Solicitation, (B) Forms of Ballots and Notices, (C) Procedures for Tabulation of Votes, and (D) Procedures for Objections; and (IV) Granting Related Relief* [Docket No. 3549] (the “Disclosure Statement Order”).

**PLEASE TAKE FURTHER NOTICE** that on January 25, 2024, in accordance with the Disclosure Statement Order, the Debtors commenced solicitation on the Second Amended Plan.

**PLEASE TAKE FURTHER NOTICE** that on February 20, 2024, the Debtors filed (a) the *Third Amended Joint Chapter 11 Plan of Reorganization of Endo International plc and its Affiliated Debtors* [Docket No. 3695] (the “Third Amended Plan”)<sup>3</sup> and (b) the *Notice of Filing of Redline of Third Amended Joint Chapter 11 Plan of Reorganization of Endo International plc and its Affiliated Debtors* [Docket No. 3696] (the “Plan Redline”).

**PLEASE TAKE FURTHER NOTICE** that the Third Amended Plan and Plan Redline may be obtained at no charge from the Debtors’ claims and noticing agent, Kroll Restructuring Administration, LLC (“Kroll”) by visiting the website maintained by Kroll at <https://restructuring.ra.kroll.com/Endo> (the “Case Website”) and (a) clicking “Plan & Disclosure Statement” located within the “Quick Links” section of the left hand navigation panel or (b) contacting Kroll via the “Live Chat” feature at the “Info Center” panel of the landing page.
