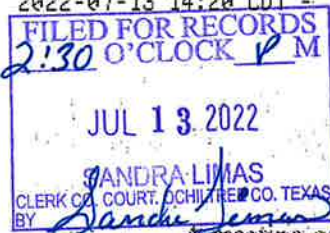


**NORTH PLAINS GROUNDWATER CONSERVATION DISTRICT
