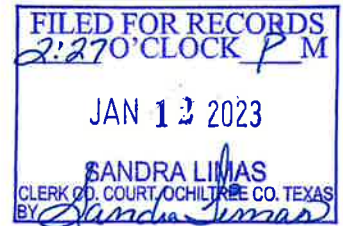


**NORTH PLAINS GROUNDWATER CONSERVATION

A meeting of the Board of Directors of North Plains Groundwater Conservation District ("District") will be held on January 17, 2023, beginning at 8:30 a.m. at the North Plains Water Conservation Center Barn, 6045 County Road E., Dumas, Texas 79029. The presiding officer and a quorum of the Board of Directors of the District will be physically present at this location.

Public comment may only be offered during this Agenda item and may either be general in nature or may address any specific item on this Agenda. General comments shall be limited to a maximum of 3 minutes, or comments on specific Agenda items shall be limited to a maximum of 3 minutes per Agenda item, not to exceed a total of 9 minutes.
