The office executing this citation shall post the copy of this citation at the courthouse door of the county in which this proceeding is pending, or at the place in or near said courthouse where public notices customarily are posted, for not less than ten days before the return day thereof, exclusive of the date of posting and return the original copy of this citation to the clerk stating in a written return thereon the time when and the place where he posted such copy.

Pursuant to Probate Code Section 632 (j), at any time after this Application is filed, a person interested in the estate or welfare of MANUEL ANTONIO GARCIA may file with the Clerk of the Court a written request that the person be notified of any or all specifically designated motions, applications, or pleadings relating to the Application or any subsequent guardianship proceeding involving MANUEL ANTONIO GARCIA after the guardianship is created, if any, filed by any person, or by a person specifically designated in the request. The person who makes the request is responsible for the fees and costs associated with the documents specified in the request. The Clerk may require a deposit to cover the estimated costs of furnishing the person with the requested notice. The Clerk by ordinary mail shall send the requesting person a copy of any document specified in the request.
