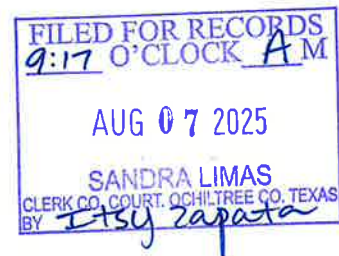


**ATTORNEYS QUALIFYING FOR APPOINTMENT TO REPRESENT INDIGENT
