FEES EFFECTIVE JANUARY 01, 2024
OFFICIAL PUBLIC RECORDS

**All recording filed with this office must have one (1) inch of space at the top of each page.
 All recording filed by mail should be accompanied by a self addressed, stamped envelope.**

The following rules will apply to all instruments recorded in Ochiltree County, as perscribed by law:

- * An instrument concerning real or personal property may be recorded if it has been acknowledged, sworn to with a proper jurat, or proved according to law. (*Property Code 12.001*)
- * Clear heading at the top of each instrument. (*Local Gov. Code 191.007(c)*)
- * Documents should not be printed in type smaller than 8 point type. (*Local Gov. Code 191.007(b)(3)*)
- * Instruments conveying real property must include the mailing address of each Grantee or the recording fee will be \$26 or twice the statutory recording fee for the instrument whichever is greater. (*Property Code 11.003*)

If any of the following requirements are not met, the instrument may still be filed for double the statutory recording fee for each page:

- * Paper size no larger than 8 1/2" X 14". (*Local Gov. Code 191.007(b)(1)*)
- * Paper of sufficient weight that there will be no bleed through or smear. (*Local Gov. Code 191.007(b)(2)*)
- * Printing, typing and handwriting should be clearly legible. (*Local Gov. Code 191.007(d)*)
- * Names must be legible printed or typed immediately under each signature. (*Local Gov. Code 191.007(e)*)
- * All photostats, photocopies and other types of reproductions must have black printing, typing or handwriting on white background, commonly known as positive prints. (*Local Gov. Code 191.007(f)*)
