To all persons interested in the welfare of the person of **RONALDO NAVARRO**, an incapacitated person, **NO. RONALDO NAVARRO, an INCAPACITATED PERSON.

Said application may be heard and acted on by said Court at any call of the docket on or after 10 o'clock A.M. on or after the 25th day of November, 2024, at the County Courthouse there of Perryton, Texas at which time and place all persons interested in the welfare of said person are required to appear by filing a written answer and contest such application should they so desire.

The office executing this citation shall post the copy of this citation at the courthouse door of the county in which this proceeding is pending, or at the place in or near said courthouse where public notices customarily are posted, for not less than ten days before the return day thereof, exclusive of the date of posting and return the original copy of this citation to the clerk stating in a written return thereon the time when and the place where he posted such copy.

You are notified that you have the right under Texas Estates Code Sec. 1051.252 to file with the Clerk a written request that you be notified of any or all specifically designated motions, applications, or pleadings filed by any person, or by a person, or by a person specifically designated in your request, relating to the application for the guardianship that has been filed or relating to any subsequent guardianship proceeding involving the ward after the guardianship is created, if any. If you make such a request, you are responsible for the fees and costs associated with the furnishing you the documents specified in the request. The Clerk may require a deposit to cover the estimated costs of furnishing you with the requested notice.

You are notified that, if you are a relative of the proposed ward as defined in Sec. 1051.103(a)(2) or (a)(4), and if a guardianship is created for the proposed ward, you must file your election in writing in order to receive notice about the health and residence of the proposed ward should a guardianship be created under Sec. 1151.056, Estates Code.
