

NOW COMES iDocket.com, LLC, (the "**Debtor**"), the Debtor in the abovereferenced bankruptcy proceeding, and files this Application for Final Decree, and would respectfully show the Court as follows:

- 1. The Debtor filed its petition for relief under Chapter 11 of the United States Bankruptcy Code on October 9, 2023 (the "Petition Date").
- 2. On March 15, 2024 the Debtor filed its First Amended Chapter 11 Plan of Reorganization [#68] (the "Plan")
- 3. On May 23, 2024, the Court entered an Order Confirming Debtor's Plan of Reorganization [Docket No. 93].

IF NO HEARING ON SUCH MOTION IS TIMELY REQUESTED, THE RELIEF REQUESTED SHALL BE DEEMED TO BE UNOPPOSED, AND THE COURT MAY ENTER AN ORDER GRANTING THE RELIEF SOUGHT.
