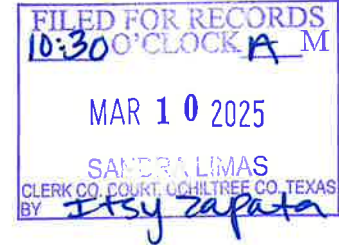

APPLICATION FOR FINAL DECREE

TO THE HONORABLE ROBERT L. JONES, U.S. Bankruptcy Judge:

NOW COMES iDocket.com, LLC, (the “Debtor”), the Debtor in the above-referenced bankruptcy proceeding, and files this Application for Final Decree, and would respectfully show the Court as follows:

1. The Debtor filed its petition for relief under Chapter 11 of the United States Bankruptcy Code on October 9, 2023 (the “Petition Date”).
2. On March 15, 2024 the Debtor filed its First Amended Chapter 11 Plan of Reorganization [#68] (the “Plan”)
3. On May 23, 2024, the Court entered an Order Confirming Debtor’s Plan of Reorganization [Docket No. 93].
4. The Debtor certifies that the Plan, has been substantially consummated. In that regard, the Debtor has already made its plan payments scheduled under the Plan.

5. The Debtor has previously filed motions seeking final approval of fees and expenses for counsel for the Debtor. An Order approving this final fee application has been entered by the Bankruptcy Court.

6. There are no motions, contested matters or adversary proceedings pending before the Court in this case.

WHEREFORE, PREMISES CONSIDERED, the Debtor would request, after notice and hearing, that the Court enter a Final Decree in this matter closing the case.

ANY RESPONSE MUST BE IN WRITING AND FILED WITH THE CLERK, AND A COPY MUST BE SERVED UPON COUNSEL FOR THE MOVING PARTY PRIOR TO THE DATE AND TIME SET FORTH HEREIN.

IF NO HEARING ON SUCH MOTION IS TIMELY REQUESTED, THE RELIEF REQUESTED SHALL BE DEEMED TO BE UNOPPOSED, AND THE COURT MAY ENTER AN ORDER GRANTING THE RELIEF SOUGHT.
