

**RESOLUTION**  
**For**  
**JOINT ELECTION AGREEMENT**  
**BETWEEN THE**  
**Perryton Independent School District**  
**And**  
**The City of Perryton, Texas**

This joint election agreement is made by and between the Perryton Independent School District ("Perryton ISD") and the City of Perryton, Texas ("the City").

WHEREAS, Perryton ISD plans to hold a Board of Trustees Election for the purpose of electing two (2) trustees for 3-year terms;

WHEREAS, the City plans to hold a City Council General Election on Saturday, May 3, 2025, for the purpose of electing three (3) council members for 2-yr terms;

WHEREAS, Texas Election Code section 271.002 authorizes the governing bodies of political subdivisions to enter into an agreement to hold joint elections in election precincts that can be served by common polling places;

WHEREAS, Texas Election Code section 271.002 requires school districts desiring to hold elections on the May Uniform Election Date to hold elections jointly with a municipality;

WHEREAS, Perryton ISD and the City will hold elections on the same day; and

WHEREAS, the parties to this agreement serve voters within the same boundaries, and it would be to the benefit of the City, Perryton ISD and the citizens and voters thereof to hold the elections jointly;

NOW, THEREFORE, IT IS AGREED that a joint election will be held by Perryton ISD and the City under the following terms and conditions:


- Separate ballots will be used by each entity.
- Each entity will be responsible for the safekeeping of their respective election records.
- Perryton ISD will tabulate and canvass their election results; the City will tabulate and canvass their election results.
- Perryton ISD will be responsible for ordering its election and will publish its notice of election. The City will be responsible for ordering its election and will publish its notice of election.
- Separate election judges, alternate judges and early voting clerks will be appointed by each entity.
- Early voting will be done separately by each entity. Perryton ISD will hold early voting at the Perryton ISD Administration Office, 821 SW 17<sup>th</sup> Avenue, from 8:00 a.m. – 5:00 p.m., April 22 – April 25, 2025 and from 8:00 a.m. – 5:00 p.m., April 28 – April 29, 2025. The City will hold early voting at City Hall, 110 S Ash, from 8:00 a.m. – 5:00 p.m., April 22 – April 25, 2025 and from 8:00 a.m. – 5:00 p.m., April 28 – April 29, 2025.
- Voting on Election Day, May 3, 2025, for both entities will be held at City Hall, 110 S. Ash, from 7:00 am - 7:00 pm.
- In the event that one of the entities has a cancellation of election, the election for the other entity will remain at City Hall.

The undersigned are the duly authorized representatives of the parties' governing bodies, and their signatures represent adoption and acceptance of the terms and conditions of this agreement.
